Expert Group Consultation on LDC Graduation Diagnostics Toolkit

Background

Research conducted by the CDP Secretariat/UN-DESA suggests that uncertainty about the LDC graduation process is a significant constraint to graduation. Such uncertainty encompasses:

- Timing of graduation
- LDC specificity of international support measures (ISMs)
- Actual use of LDC-specific ISMs
- Impact of graduation on ISMs
- Likely impact of graduation on development
- Managing graduation
- Nature of smooth transition strategy

Uncertainty cannot be fully eliminated but it can be reduced and managed through identifying its sources, providing and explaining how to obtain and use detailed information. LDC governments and other stakeholders have expressed interest in assistance from the CDP Secretariat with addressing this source of uncertainty.


To this end the CDP Secretariat is developing a graduation diagnostics toolkit aimed at helping countries clarify the procedure and remove some of the uncertainty surrounding the process. Three pilot countries, Uganda, Bhutan and Nepal, will be used to test the toolkit and to develop it before it is offered to a wider audience. The goals of the toolkit are to assist in better understanding LDC-specific support and better preparing for graduation. Objectives include:

- Accessing graduation data
- Mapping out type of LDC specific support received
- Identifying relevant sectors and impact of ISMs
- Assessing impact on development progress
- Promoting collaboration between stakeholders with the aim of enhancing support and integration of graduation across the private sector, civil society and government
- Identifying policy priorities for successful graduation
- Establishing a roadmap to graduation
- Integrating smooth transition strategy in development strategies
- Facilitating transition strategy

The main potential users of the toolkit are expected to be officials from the Ministries of Planning, Finance and Trade and related agencies in at least 16 countries that may graduate, become eligible or be recommended for graduation in coming years, including: Angola, Bangladesh, Bhutan, Cambodia, Equatorial Guinea, Kiribati, Lao PDR, Lesotho, Myanmar, Nepal, Sao Tome and Principe, Solomon Islands, Timor Leste, Tuvalu, Uganda and Vanuatu. The tool should facilitate collaboration and be useable by different stakeholders within each country and possibly at the regional level.

It is anticipated that the toolkit will guide the user through a list of targeted questions via an appropriate interface such as a website or other ICT-facilitated procedures. The answers can be stored and a final report on smooth transition will be delivered, with links to appropriate sources of information, ISMs (linked to the LDC portal), and recommendations for further action. In those cases where the toolkit cannot provide answers, suggestions for further research will be made.
